- 2. 2020-2024 TIP Discussion
 - a. PIN 5763.32 McKinley Pkwy; Quinby Rd to Rt 20 Southwestern Blvd This Erie County request is to move \$0.300M from the Construction Phase (C&CI) to the Design Phases (Preliminary and Detailed). Pre-Design will increase by \$150K. Detailed Design will increase by \$150K. Overall project cost remains the same. Fiscal constraint is maintained as funding will be transferred from a different phase of the same project. Let date will remain 12/15/2023. *Motion to approve as AdMod #119: Svilokos/Hill. Approved.*

Old Business

- a. 2023-2027 TIP Development MTP Linkage Summary Guarino stated that a MTP Linkage methodology has been developed by staff to evaluate how TIP projects relate to the MTP Goals and objectives. Dixon presented a summary of submitted TIP candidate projects was broken down by MTP linkage (poor, fair or good) for each member agency who has submitted project candidates. The next steps in the TIP update are to incorporate NYSDOT projects when available and review overall TIP-MTP alignment. Members were asked for thoughts or suggestions to improve the process moving forward. There were some questions on the scoring process. Suggestions were made by Dixon on how maintenance project submission could be improved to receive a higher MTP linkage score. Members were reminded that he MTP linkage score is just one of many factors that should be used when they prioritize their final project listings.
- b. 2023-2027 TIP Development Candidate Project Presentations The summarized candidate projects lists were shared and sponsors/members were given the opportunity to summarize/discuss submitted projects.

4. New Business

- a. RPPM Change Report PIN 5350.01 NY 187 (Transit Rd) @ Milestrip Rd, Intersection Safety Improvements. ROW Acq Phase moved from FFY21 to FFY22. Approved 1/11/2022.
- b. Bridge Formula Program Guidance Guarino explained the program. Congress had established the BFP to provide funding for highway bridge replacement, rehabilitation, preservation, protection, and construction projects on public roads in the IIJA. This program is funded by the General Fund of the US Treasury under Advanced Appropriations and not by the Highway Trust Fund (HTF). \$5.5B is available for obligation until September 30, 2025 (a 4-year life like Contract Authority from the HTF). Funds are distributed to the States by a statutory formula based on the relative costs of replacing all highway bridges classified in poor condition in a State and the relative costs of rehabilitating all highway bridges classified in fair condition in a State. NY State is to receive \$378.4M: \$321.7M for on-system and \$56.8M for off system. BFP funds shall be used for highway bridge replacement, rehabilitation, preservation, protection, or construction projects on public roads. The Federal share for costs reimbursed with BFP funds under this program for an off-system highway bridge owned by a county, town, township, city, municipality or other local agency, or federally-recognized Tribe shall be 100%. FHWA encourages States to use BFP funding on off-system bridges in proportion to the scale of each State's off-system bridge needs. New bridge construction is allowed but FHWA encourages states to focus on improving NBI "poor" and preserving NBI "fair" bridges. FHWA encourages the use of BFP funds for projects that address equity, barriers to opportunity, challenges faced by individuals and underserved communities in rural areas, or restoring community connectivity.
- Planning Emphasis Areas (PEA) Guarino reported that FTA and the Federal Highway Administration (FHWA) issued guidance on updated Planning Emphasis Areas (PEAs). FTA and FHWA field offices have been asked to work with their Metropolitan Planning Organizations, State Departments of Transportation, transit agencies, and federal land management agencies to incorporate these PEAs into their Unified Planning Work Programs and State Planning and Research Work Programs. Several of these emphasis areas focus on the goals of advancing equity and environmental justice in transportation planning. There is considerable flexibility in how MPOs and State DOTs can incorporate the PEAs into the transportation planning process. Recognizing the variability and timing of transportation planning processes, FTA and FHWA encourage these PEAs to be incorporated as programs are updated: Tackling the Climate Crisis - Transition to a Clean Energy, Resilient Future; Equity and Justice 40 in Transportation Planning; Complete Streets; Public Involvement; Strategic Highway Network (STRAHNET)/U.S. Department of Defense (DOD) Coordination -Transportation planning and project programming process on infrastructure and connectivity needs for STRAHNET routes and other public roads that connect to DOD facilities; Federal Land Management Agency (FLMA) Coordination -Explore opportunities to leverage transportation funding to support access and transportation needs of FLMAs before transportation projects are programmed in TIP/STIP; Planning and Environment Linkages (PEL) – Considers environmental, community, and economic goals early in the transportation planning process, and uses the information, analysis, and products developed during planning to inform the environmental review process; Data in Transportation Planning – Improved data sharing and management.










FHWA Small Town and Rural Multimodal Networks Guide





Bridge Formula Program Guidance 1/3

- Congress established the BFP to provide funding for highway bridge replacement, rehabilitation, preservation, protection, and construction projects on public roads in the IIJA.
- This program is funded by the General Fund of the US Treasury under Advanced Appropriations and not by the Highway Trust Fund (HTF).
- \$5.5B is available for obligation until September 30, 2025 (a 4-year life like Contract Authority from the HTF).
- Funds are distributed to the States by a statutory formula based on the relative costs of replacing all highway bridges classified in poor condition in a State and the relative costs of rehabilitating all highway bridges classified in fair condition in a State..
- NY State \$378.4M
 - \$321.7M (on-system)
 - \$56.8M (off system)

Bridge Formula Program Guidance 2/3

- BFP funds shall be used for highway bridge replacement, rehabilitation, preservation, protection, or construction projects on public roads.
- The Federal share for costs reimbursed with BFP funds under this program for an off-system highway bridge owned by a county, town, township, city, municipality or other local agency, or federally-recognized Tribe shall be 100 percent.
- FHWA encourages States to use BFP funding on off-system bridges in proportion to the scale of each State's off-system bridge needs.
- New bridge construction allowed but FHWA encourages states to focus on improving NBI "poor" and preserving NBI "fair" bridges.
- FHWA encourages the use of BFP funds for projects that address equity, barriers to opportunity, challenges faced by individuals and underserved communities in rural areas, or restoring community connectivity.

Bridge Formula Program Guidance 3/3

- All projects with Federal financial participation (including under BFP) that replace or rehabilitate a highway bridge deck are required to provide safe accommodation of pedestrians or bicyclists, as applicable, on the bridge, when both of the following conditions are met:
 - The bridge is located on a highway on which pedestrians or bicyclists are allowed to operate at each end of the bridge, and
 - FHWA determines that safe accommodation can be provided at reasonable cost.

Planning Emphasis Areas

- FTA and the Federal Highway Administration (FHWA) issued updated Planning Emphasis Areas (PEAs).
- FTA and FHWA field offices have been asked to work with their metropolitan planning organizations, state Departments of Transportation, transit agencies, and federal land management agencies to incorporate these PEAs into their Unified Planning Work Programs and State Planning and Research Work Programs.
- Several of these emphasis areas focus on the goals of advancing equity and environmental justice in transportation planning.
- There is considerable flexibility in how metropolitan planning organizations and State DOTs can incorporate the PEAs into the transportation planning process.
- Recognizing the variability and timing of transportation planning processes, FTA and FHWA encourage these PEAs to be incorporated as programs are updated.

There is a request from NYSDOT to make this a 3-year project going forward. This action will fund the SFY 22/23 portion (year 1) at a cost of \$2.670M. Year 2 and 3 will be funded on the next TIP. Offset will be provided by the remaining funds in existing NITTEC PIN 5814.45 (\$2.578M) and Statewide Capital Funding (\$0.122M). *Motion to initiate a 20-day public review: Buffamonte/Svilokos. Approved.*

2. 2020-2024 TIP Discussion

- a. PIN 5814.53 Rt 952Q (Walden Av); Town of Lancaster; Operational Improvements This is a NYSDOT request for a minor scope change to an existing project. Additional work to include signal rehabilitation work at Walden Av @ Cemetery Rd & Walden Av @ Pavement Rd and sidewalks to be installed on the north side of Walden Av from Seneca Pl to Stony Rd. All signage to be replaced. C&CI will be increased by \$0.784M (Total C cost will be \$2.625M). Fiscal constraint is maintained as the additional \$0.784M will be from 100% State Discretional Funds (SDF). Let date will remain 6/2022. *Motion to recommend to PCC for approval: Hill/Svilokos.. Approved.*
- b. Bridge NY Projects Five bridges in the MPO area were chosen for funding. NYSDOT Asked that the local agencies submit a list of their bridges that did not receive funding for this round of BRIDGE NY Projects for illustrative purposes.
- c. Thruway Interchange Requests There have been two Thruway interchange requests from local municipalities. One is an existing request at Youngs Rd in Amherst. The other request is new at Gunnville Rd in Lancaster. It was pointed out that these requests should be included on the Long Range Plan so they can be part of future expansion projects based on the following criteria. An interchange can be a useful and an adaptable solution for many intersection problems either by reducing existing traffic bottlenecks or by improving safety.
 - The high cost of constructing an interchange requires that expenditure be justified. The following six conditions, or warrants, should be considered when determining if an interchange is justified at a particular site: 1. Providing highway grade separations or interchanges for all intersecting roadways crossing the highway. 2. Reduction of bottlenecks or spot congestion. 3. Safety improvement. 4. Site topography. 5. Road-user benefits. 6. Traffic volume.
 - The FHWA process to approve new access points to the Interstate System must be supported by substantiated information justifying and documenting that decision. Any proposed change in access can be submitted by a State DOT to the FHWA division office for a determination of safety, operational, and engineering acceptability. State DOTs must submit requests for proposed changes in access to their FHWA Division Office for review and action. FHWA Division Office will ensure that all requests for changes in access contain sufficient information, as required in this policy, to allow FHWA to independently evaluate and act on the request.
 - Requests for a proposed change in access should include a description and assessment of the impacts and ability of the proposed changes to safely and efficiently collect, distribute, and accommodate traffic on the Interstate facility, ramps, intersection of ramps with crossroad, and local street network (23 CFR 625.2(a) and 655.603(d)). Each request should also include a conceptual plan of the type and location of the signs proposed to support each design alternative (23 U.S.C. 109(d) and 23 CFR 655.603(d)).







- 2. 2020-2024 TIP Discussion
 - a. PIN 5815.58 HELP Program Project Merger This is a NYSDOT request to merge two (2) existing Highway Emergency Local Patrol (HELP) truck programs: PIN 5809.38 (I-290) \$0.972M matched NHPP and PIN 5809.39 (NY Rt 33) \$1.054M matched NHPP. FHWA has requested a new 3-year project/PIN 5815.58 \$2.026M matched NHPP for the merged projects. After ICG consultation, the air quality conformity exemption code for the combined projects will remain A7 (Traffic control devices and operating assistance other than signalization projects). *Motion to approve as Administrative Modification #121: Buffamonte/Svilokos. Approved.*
 - b. PIN 5763.14 Raymond Rd; Dysinger Rd to Rapids Rd This Niagara County request will advance the existing pavement project. The current let is 4/24/2024 (FFY 24). The requested let is 6/15/2023 (FFY 23). The project total will increase by \$0.2M. Per NYSDOT instruction, no offset is needed to advance this project. Fiscal constraint is maintained. *Motion to approve as Administrative Modification #122: Buffamonte/Svilokos. Approved.*
 - c. PIN 5763.47 Parker Blvd Complete Streets This NYSDOT request will move the let date from FFY 23 to FFY 22. \$8K of Federal funds from ROW Phases are being moved to Construction, as sponsor (Town of Tonawanda) is covering ROW I & ROW A. \$110K of Local funds for Construction Inspection are being added to the TIP as CI was planned to be locally funded from project initiation, but funds are not currently shown on the TIP. Fiscal constraint is maintained. *Motion to approve as Administrative Modification #123: Buffamonte/Svilokos. Approved.*

3. Old Business

a. 2023-2027 TIP Development Update – TIP/STIP guidance from NYSDOT MO was received on March 25, 2022. It included preliminary regional planning targets that may be used to inform the development of the FFY 23-26 STIP update and a number of issues need to be addressed as part of the State budget to develop fully developed targets. The new five-year State capital plan will fully incorporate the estimated \$13.5B in formula funding under the BIL. State/Federal funding balance is being realigned. TIP approval resolution is needed by July 18, 2022. Transit (FTA) targets were not included and will be sent separately. Buffamonte requested that the preliminary planning target be shared with members. This info will be distributed electronically following the meeting.

 - c. PIN 5045.27 NY Rt 104 and NY Rt 93 Intersection Safety Improvements Increases ROW INC by 0.011M from PIN 5B15.55 Pavt Maint Block. Moves ROW Phase from FFY21 to FFY22. Approved 4/11/2022.
 - d. PIN 5763.14 Raymond Rd; Dysinger Rd Rapids Rd Moved the Obligation Date for Prelim Design from FFY21 TO FFY22. Approved on 4/12/2022.
- b. USDOT Multimodal Project Discretionary Grant Opportunity The Bipartisan Infrastructure Law established two new programs and reauthorized one preexisting program which are being solicited together. Mega: \$1B of FFY22 funding for the National Infrastructure Project Assistance grants program, known as the "Mega" grants program; Rural: \$300M in FFY22 funding for the Rural Surface Transportation Grant program, known as "Rural"; and INFRA: Approximately \$1.55B in FFY22 funding to be made available for the Nationally Significant Multimodal Freight and Highways Projects grants program, known as "INFRA". Because of the shared characteristics of the 3 programs, it is possible for many projects to be eligible and considered for multiple programs using a single application. Application Deadline is May 23, 2022 11:59 PM Eastern. Selections will happen in the Fall of 2022. Project Requirements: Generates national or regional economic, mobility, or safety benefits (Mega/INFRA/Rural); Cost-effective (Mega/INFRA/Rural); contributes to one or more goals (INFRA/Rural) Safety, infrastructure condition, congestion reduction, system reliability, freight movement and economic vitality, environmental sustainability and reduced project delivery delays; based on the results of preliminary engineering (INFRA/Rural); one or more stable and dependable funding or financing sources (Mega/INFRA); cannot be completed easily or efficiently without Federal funding/The project is in significant need of Federal funding (Mega/INFRA); reasonably expected to begin construction 18 months from obligation; the applicant has or will have the sufficient legal, financial, technical capacity to carry out the project. INFRA Small Project Considerations: Costeffectiveness and effect on mobility in the project's State or region.
- c. Bridge Investment Program A new discretionary program NOFA is scheduled to be released in May. The purpose of the program is to improve bridge (and culvert) conditions, safety, efficiency, and reliability. Funding: \$12.5B (FFY22-26), including \$3.3B (FFY22-26) in Contract Authority from the HTF and \$9.2B (FFY22-26) in advance appropriations from the GF. Eligible entities include: State, MPO (Population >200K), Local government, Special purpose district or public authority with a transportation function, Federal land management agency, and Tribal government. Eligible project types include: Replace, rehabilitate, preserve or protect one or more bridges on the National Bridge Inventory

- (NBI), replace or rehabilitate culverts to improve flood control and improve habitat connectivity for aquatic species. Other key provisions: At least 50% of funding reserved for certain large projects; option for multi-year funding agreements, different process for funding projects that are less than \$100M, and sets aside an average of \$40M per FFY for Tribal transportation bridges.

- e. Upcoming Local Projects Meetings The next round of Local Projects Meetings will be scheduled soon. Unamended obligation rates were shown from 2014. Trend line over that period is positive and for the last two years, the rate has been above the 75% goal.
- f. Moving Forward 2050 MTP Update The MTP serves as a framework for the Transportation Improvement Program and is updated on a five-year cycle. The current MTP, Moving Forward 2050, was approved in May 2018. The update will maintain the 2050 planning horizon, reaffirming key elements and concepts of the current 2050 Plan. Demographic, land use and transportation conditions will be updated to reflect the most current data available. There will be an update of financial resources available to the region to implement MTP projects based on new federal transportation legislation. It will address the status of significant planning studies, initiatives and projects underway since 2018. It will address federal planning requirements as specified in new federal transportation legislation, including a System Performance Report for federal performance measures. Members were queried about how they would like to participate in the upcoming update process.





1. Approval of April 20, 2022 TPS Meeting Summary - Motion for approval: Svilokos/Allen. Approved.

2. 2020-2024 TIP Discussion

- a. PIN 5350.01 NY 187 (Transit Rd) @ Mile Strip Rd This NYSDOT request is to increase C&CI by \$0.349M (total Construction cost will be \$1.408M). Funding to provide additional Signal, CARDS, Hydrant & DI work. Fiscal constraint maintained as \$0.349M will be transferred from PIN 5B20.11 (HSIP CARDS/PED Signal Program Block Fund). Let date remains 7/2022. *Motion to approve as Administrative Modification #124: Buffamonte/Svilokos. Approved.*
- b. PIN 5762.66 City of Buffalo PSAP This City of Buffalo action will add local funds to the Construction Phase to accommodate additional signal items. The project total will increase by \$0.194M. Fiscal constraint is maintained as the additional \$0.194M is local funds. The current let is 4/15/2022 (FFY 22) and the requested let is 7/1/2022 (FFY 22). *Motion to approve as Administrative Modification #125: Kempner/Skipper. Approved.*
- c. PIN 5763.48 Busti Av Traffic Calming & Bicycle Improvements This request from the City of Buffalo is a minor scope change. The project limits on Busti Av will be expanded from Virginia St Porter St to Virginia St Massachusetts Av. COB will add \$0.711M of local funds to Design and C & CI to accommodate the new limits. The let date will be delayed from 4/15/2021 (FFY21) to 9/1/2022 (FFY22). Fiscal constraint is maintained as \$0.711M of local funds will be added to the project. Motion to recommend to PCC as Administrative Modification #126: Buffamonte/Skipper. Approved.
- d. FTA 5310 Project Candidates NYSDOT MO still hasn't released the final list of projects yet. COVID money has been added but hasn't been clearly stated as to how it can be spent. This item will be added to the next PCC meeting when the final list of projects should be available for review.
- e. Region 5 TÎP Project Candidates The Region 5 Candidate Project list was released. There are more actual projects listed this time than block funding. NYSDOT encouraged member agencies to review the list and contact them with questions or comments. This list of candidate projects will be pared down, along with the other member agencies lists, to eventually fit the constrained budget for the new TIP.

3. Old Business

a. 2023-2027 TIP Development Update – NYSDOT MO gave all regions permission to release their project listings. MPOs are encouraged to have their TIP approved and submitted by August 18, 2022. This is another 30-day extension. The updated schedule looks like this: Final project listing needs to be approved by PCC on July 6, 2022, with a 30-day review for the draft TIP and conformity document. Public meetings need to held to present draft TIP. It then needs to be sent for Interagency consultation and to FHWA/FTA and NYSDOT MO. On August 3, 2022 PCC will recommend the draft TIP and draft conformity document to Policy for approval. On August 15, 2022 Policy meeting will be held to approve the TIP and conformity document. By August 18, 2022 TIP transmittal will take place and finally on November 1, 2022 the new TIP will be live.

4. New Business

- a. RPPM Change Report There were five (5) RPPM changes completed since the last meeting:
 - a. PIN 5763.81 East Canal Rd Bridge (BIN 3329070) and PIN 5763.82 Hartland Rd Over Fish Creek (BIN 2213670): The obligation date for Detailed Design Phase was advanced from FFY23 to FFY22. Approved on 4/21/2022.
 - b. PIN 5763.70 Bridge Deck Overlays 2022 (5 BINs); Niagara County: Adjusts the phase split and cost, no change in total project cost. Approved on 4/22/2022.
 - c. PIN 5814.03 ADA Compliance Project At Various Federal Aid Eligible Locations: Increased Preliminary Design for PIN 5814.03 by \$0.132M with offset provided by PIN 5B14.23 Sidewalk Program At Various Federal Aid Eligible Locations. Approved on 5/3/2022.
 - d. PIN 5814.03 ADA Compliance Project At Various Federal Aid Eligible Locations: Added \$135K to Preliminary Design (SDF Offset). Approved on 5/6/2022.
 - e. PIN 5763.49 Erie County Installation Of New Electric Vehicle Charging Stations: Added \$122K local funds to Construction Phase. Approved 5/9/2022
- b. USDOT Reconnecting Communities Pilot Discretionary Grant Program \$1B will be available over the next 5 years to support planning, capital construction, and technical assistance to equitably and safely restore community connectivity through the removal, retrofit, mitigation, or replacement of eligible transportation infrastructure facilities that create barriers to mobility, access, or economic development. Planning grants may be used to study the feasibility and impacts of removing, retrofitting, or mitigating an existing eligible facility or to conduct planning activities necessary to design a project to remove, retrofit, or mitigate an existing eligible facility.



 - a. Reducing the number of bridges in poor condition or in fair condition
 - b. Reducing the total person miles traveled over bridges in poor condition, or in fair condition
 - c. Reducing the number of bridges that do not meet current geometric design standards, or cannot meet the load and traffic requirements typical of the regional transportation network
 - d. Reducing the total person miles traveled over bridges that do not meet current geometric design standards, or cannot meet the load and traffic requirements typical of the regional transportation network
 - 3. Provide financial assistance that leverages and encourages non-Federal contributions from sponsors and stakeholders involved in the planning, design, and construction of eligible projects.

c. 2022 BIP - Bridge Investment Program (2/5)

- Eligible applicants may submit applications for any of the three funding categories, but each category has distinct eligibility and selection criteria and application deadlines.
 - A State or a group of States.
 - A metropolitan planning organization that serves an urbanized area (as designated by the Bureau of the Census) with a population of over 200,000.
 - A unit of local government or a group of local governments.
 - A political subdivision of a State or local government.
 - A special purpose district or public authority with a transportation function.
 - An FLMA.
 - A Tribal government or a consortium of Tribal governments.
 - A multistate or multijurisdictional group of entities described above. [§11118(a); 23 U.S.C. 124(d)]
- Three categories of funding opportunities include:
 - 1. Planning
 - 2. Large Bridge Projects (projects with eligible costs greater than \$100 million)
 - 3. Bridge Projects (projects with eligible costs less than \$100 million)

c. 2022 BIP - Bridge Investment Program (3/5)

 Allows up to 5% of BIP funding per year to be used for eligible projects that consist solely of culvert replacement or rehabilitation of bridge-sized culverts

Minimum Grant Size

- There is no minimum size for planning grants
- Requires a grant awarded under BIP to be at least—
 - Enough to fully fund the project (combined with other resources listed in the application); and
 - \$50 million for "Large Bridge Projects"
 - \$2.5 million for "Other Bridge Projects"

Federal Share

- Up to 50% for "Large Bridge Projects"
- Up to 80% for other BIP projects
- Up to 90% for off-system bridges

c. 2022 BIP - Bridge Investment Program (4/5)

Planning

- A total of \$20 million in 2022 BIP funds are available for Planning funding opportunities.
- These funds will be awarded on a competitive basis for planning, feasibility analysis, and revenue forecasting associated with the development of a project that would subsequently be eligible to apply for BIP funding under either the Bridge Projects or Large Bridge Projects funding categories.

Bridge Projects and Large Bridge Projects

- A total of \$2.36 billion in 2022 BIP funds are available for the Bridge Projects and Large Bridge Projects funding opportunities.
- These funds will be awarded on a competitive basis for bridge replacement, rehabilitation, preservation, and protection projects
- Large Bridge Projects that receive a BIP award of not less than \$100 million are eligible for multiyear grants, in which DOT can award available funds to a project over the course of several years in accordance with an agreement and in alignment with its schedule.
- In selecting Bridge Projects and Large Bridge Projects, FHWA will consider the extent to which BIP funds leverage non-Federal contributions from sponsors and stakeholders involved in the planning, design, and construction of eligible projects.

c. 2022 BIP - Bridge Investment Program (5/5)

Important dates

- Planning Applications must be submitted by 11:59 p.m. EDT on July 25, 2022.
- Bridge Project Applications must be submitted by 11:59 p.m. EDT on September 8, 2022.
- Large Bridge Project Applications must be submitted by 11:59 p.m. EDT on August 9, 2022.
- Grants.gov will open by June 10, 2022, for all three funding categories.

d. Pilot Program for Transit-Oriented Development Planning (FTA)

- Approximately \$13 million available for Fiscal Year 2022 funding to help communities integrate land use and transportation planning in new fixed guideway and core capacity transit project corridors.
- Existing competitive grant program (since 2015).
- Applicants must be FTA grantees.
- Plans must examine ways to improve economic development and ridership potential, foster multimodal connectivity and accessibility, improve transit access for pedestrian and bicycle traffic, engage the private sector, identify infrastructure needs, and enable mixed-use development near transit stations.
- NFTA won \$641K in 2015 and \$778K in 2018 for light rail extension TOD planning.

The Draft TIP and Transportation Conformity Determination was sent electronically for interagency review and comment. The Draft TIP was sent electronically to local elected leaders. ICG is reviewing the Draft Transportation Conformity Determination. Two TIP Public Meetings will be held on August 22, 2022 one in person/streamed in the morning and one just streamed in the evening. On September 7, 2022 GBNRTC PCC is scheduled to recommend the Draft Transportation Conformity Determination and TIP. - b. Safe Streets for All (SS4A) Planning Grant Application The Bipartisan Infrastructure Law (BIL) established this new program that supports regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. It will include \$5-6 Billion in grants over the next 5 years and supports the Department's National Roadway Safety Strategy and a goal of zero deaths and serious injuries on our nation's roadways. Eligible activities include developing or updating a "Comprehensive Safety Action Plan" or Action Plan (e.g., Vision Zero plans), conducting planning, design, and development activities in support of an Action Plan, and implementing projects and strategies identified in an Action Plan. Metropolitan Planning Organizations are eligible to apply. The USDOT does not want duplicate application from the same geographic areas so the GBNRTC has committed to applying for a planning grant that will cover all municipalities in the 2 county MPO planning area. The deadline for applications remains unchanged as 5:00 p.m. EDT on September 15, 2022. Once the plan has been submitted, any project identified is eligible for implementation funding (owner of facility). Some issues that need to be discussed and defined include how the 20% match will be paid, what is a reasonable cost for such a study, what type of reduction are we looking to achieve (percentage or zero). Member concurrence with goals of planning study and commitment to assist in developing projects to achieve them.

- Metropolitan Planning Organizations are eligible to apply.

b. GBNRTC Safe Streets for All (SS4A) Planning Grant Application


- The USDOT does not want duplicate application from the same geographic areas.
- GBNRTC has committed to applying for a planning grant that will cover all municipalities in the 2 county MPO planning area.
- The deadline for applications remains unchanged as 5:00 p.m. EDT on September 15, 2022.
- Once the plan has been submitted, any project identified is eligible for implementation funding (owner of facility).
- Some issues that need to be discussed and defined include:
 - How will we pay for the 20% match?
 - What is a reasonable cost for such a study?
 - What type of reduction are we looking to achieve (percentage or ZERO)?
 - Member concurrence with goals of planning study and commitment to assist locals when they apply for implementation grants (if requested) via Resolution.
 - Anything else?


b. Rebuilding American Infrastructure with Sustainability and Equity (RAISE) 2022 Awards (National)

2. 2020-2024 TIP Discussion

- a. PIN 5813.79 Pavt Markings North/Line 1; Erie & Niagara Counties This is a NYSDOT request to modify an existing project. This action will replace \$0.966M of NHPP funding with SDF. The project cost remains unchanged and fiscal constraint is maintained. The let date is unchanged and will remain 11/17/2022. *Motion to approve as Administrative Modification #133: Buffamonte/Svilokos. Approved.*
- b. PIN 5813.72 Guiderail Replacement; Various Locations This is a NYSDOT request to modify an existing project. Construction Phase funding will be advanced from 10/2022 (FFY 23) to 9/2022 (FFY 22). The project costs are unchanged and the let date has been changed to 9/2022. *Motion to approve as Administrative Modification #134: Buffamonte/Svilokos. Approved.*

3. Old Business

- a. 2023-2027 TIP Development Status NYSDOT MO has received an electronic copy of the 2023-2027 TIP for review and inclusion into the STIP. Before the 2023-2027 TIP can go to print, some minor changes need to be made NYSDOT MO asked that some funding categories be changed. The project summary tables for each member also need to be revised to reflect those projects that may have been obligated but won't be finalized before the start of the new TIP. The member agencies agreed to only include these projects on the summary tables so therefore project details will not be added.
- b. Safe Streets for All (SS4A) Planning Grant Application The Bipartisan Infrastructure Law (BIL) established this new program that supports regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. It includes \$5-6B in grants over the next 5 years and supports the Department's National Roadway Safety Strategy and a goal of zero deaths and serious injuries on our nation's roadways. Projects and strategies must be defined in a "Comprehensive Safety Action Plan" or Action Plan (e.g., Vision Zero plans) for facility owners to be eligible for implementation funds. GBNRTC has applied, through NFTA, for a SS4A planning grant to complete the required Action Plan. It will be consultant led (RFP), cover the entire GBNRTC planning area (Erie and Niagara Counties), consider the safety of all streets, roads and highways, regardless of ownership, examine crash and infrastructure characteristics, geographic trends, and contributing risk factors to develop a plan for implementing Safe System changes that emphasize complete streets, proven safety countermeasure best practices, pedestrian and bicycle safety, accessibility, and historically underserved communities, with the goal of elimination of fatalities by 2050 and a 50% reduction of serious injuries by 2050. The estimated study cost is \$562,500. The federal share is \$450,000 and the non-federal match is \$112,500 (20%) which split between the following: Erie County (\$25K), City of Buffalo (\$15K), Niagara County (\$10K), NYSDOT (\$50K), and member in-kind (\$12.5K). The planning grant application was submitted on September 15, 2022

New Business

- a. RPPM Change Report PIN 5763.80 State Street Over Murder Creek The obligation date for Detailed Design Phase was moved from FFY 23 to FFY22. Approved 8/25/2022. PIN 5813.72 Guiderail Replacements at Various Locations (Catt, Chaut, EC) The C&CI Phase was increased by a total of \$0.138M. The offset comes from PIN 5B15.55 (PMI PAVT Maint Let & VPP Block Fund). Approved 9/13/2022. PIN 5814.20 Large Culvert Preservation at Various Locations ROW Acquisition Phase was increased by \$0.038M. The funding was transferred from PIN 5B15.55 PMI-Pavt Maint Let & VPP Block Fund. Approved 9/14/2022.
- 2050 MTP Update Draft Financial Forecasts & Assumptions Financial forecasts form the basis of fiscal constraint for MTP. They provide an indication that projects identified in the MTP have sufficient resources for completing them. Requirement for this is stated in CFR 450.324: Development and Content of the Metropolitan Transportation Plan. Section 11 states that a financial plan that demonstrates how the adopted transportation plan can be implemented is required. All necessary financial resources that are reasonably expected to be made available are to be identified. Moving Forward 2050, completed in 2018, included an extensive review of available financial resources and these were incorporated in the approved document. Fund sources where no changes had occurred were utilized for the remainder of the MTP 2050 Update. Significant changes occurred in both Federal and State programs, these were analyzed and incorporated in forecasts for this update. New federal legislation, the first in years was approved by Congress: The Infrastructure Investment and Jobs Act (IIJA), aka Bipartisan Infrastructure Law, Public Law 117-58, provides a significant increase in formula revenues for transportation programs and multiyear certainty in funding. New discretionary programs were also included. The New York State Five Year Capital Program was also approved, indicating specific projects and funding levels for various programs. These were incorporated into the Moving Forward 2050 Update financial forecasts. Forecasts are based on reasonable assumptions with credible evidence. Previously approved items were kept the same if there were no changes. Items affected by recent legislation were revised to reflect those changes. Overall revenue estimates are given as: 2023 - 2030: \$5,713B; 2031 - 2040: \$7,088B; 2041 - 2050: \$9,415B; for a total of: \$22,216B.

- c. Town of Amherst N Bailey Av Project The Town of Amherst is looking at funding opportunities for their N Bailey Av project. The town had previously submitted the project as a TIP Candidate but it was not selected for the constrained project listing, leaving its status as "illustrative". Amherst is investigating alternative federal funding sources to use in addition to developer contributions. Some members were concerned how this project would affect their adjacent roads and asked to see a more detailed plan for this project, along with a complete traffic study. Amherst was invited to present a modified project proposal to TPS at a future time.
- d. NEVI Program GBNRTC staff are currently working on developing a plan for this program. They will present an update at a future TPS meeting.
- e. Freight Plan It is now a federal requirement that each state must update their freight plan every four years. In addition, plans must now include a trucking parking inventory and analysis of truck parking gaps.

And this action will add bridge deck overlay work to BIN 3060430 Quaker Rd/Golden Hill Creek, BIN 3329360 Mapleton Rd/Bull Creek, and BIN 3329430 Pearson Rd/Jeddo Creek. \$80K STBGP Flex will be replaced with \$80K OSB. Project total is unchanged therefore fiscal constraint maintained. *Motion to recommend to PCC for approval as Administrative Modification #136: Allen/Hill. Approved.*

a. 2023-2027 TIP Development Status – The 2023-2027 TIP is still out for review. Member agencies were informed they can start working on IPPs for new TIP projects in the meantime, however funding cannot be obligated until the new TIP is approved. Member agencies were asked how many hard copies of the 2023-2027 TIP each are requesting. The status of an Erie County carryover project was discussed and will be looked into by NYSDOT, EC, and GBNRTC.

4. New Business

- a. RPPM Change Report No RPPM changes to report since 9/14/2022. An electronic TPS ballot approved on 9/21/2022. It modified the funding sources for the three existing projects: PIN 5111.77 US 20/Cazenovia Creek (Bridge Formula Program (BFP) replacing NHPP), PIN 5814.07 Bridge Rehabilitation 3 Bridges; Erie County (Bridge Formula Program (BFP) replacing NHPP), and PIN 5512.52 Kensington Corridor Project (NYW PIT replacing NHPP). Funding totals for all three projects remain unchanged.
- b. Upcoming BRIDGE NY Solicitation MPOs were provided a preview of the upcoming solicitation for BRIDGE NY. The solicitation and scoring will be done at the local level. MPOs will be coordinating for MPO areas and NYSDOT will be coordinating for counties outside of MPOs. NYSDOT is recommending that MPOs follow the BRIDGE NY model for solicitation and scoring candidates but that's not mandatory. MPOs can use their own process so long as it includes extensive outreach to locals that own bridges but aren't MPO members. The funding is being designated to each county for all county/local bridges within that county. The funding designated for each county cannot be amended by an MPO where MPOs represent multiple counties. NYSDOT emphasized that there is a lot of funding available for off-system bridges so the analysis may need to separate off-system from on-system bridges. Off-system bridges may be able to be funded even if they score lower than on-system bridges just due to the nature of available funds. More details will be provided at the State Bridge Conference and NYSDOT anticipates being able to release the funding shortly after the conference. MPOs will do their own reviews in-house. NYSDOT has bridge data for all bridges including all locals but not necessarily culvert data. Locals would be responsible for their own culvert data. GBNRTC staff also maintains a database of historical National Bridge Inventory (NBI) bridge data.
- Thriving Communities Program This program aims to ensure that disadvantaged communities adversely or disproportionately affected by environmental, climate, and human health policy outcomes have the technical tools and organizational capacity to compete for federal aid and deliver quality infrastructure projects that enable their communities and neighborhoods to thrive. Facilitates the planning and development of transportation and community revitalization activities and provides tools to ensure that under-resourced communities can access the historic funding provided in the Bipartisan Infrastructure Law (BIL). Intended for teams of community partners that may lack the staffing or technical expertise to scope, fund, and develop infrastructure projects that advance broader community goals. For selected communities, the Thriving Communities Program will provide two years of deep-dive assistance to help them plan and develop a pipeline of comprehensive transportation, housing, and community revitalization activities. This funding is available to: state, local or tribal government agencies, MPOs, transit agencies, and political subdivisions of state or local government. This program will be funded with \$25M through the Consolidated Appropriations Act of 2022. There are two separate response opportunities available for potential applicants a Letter of Interest and a Notice of Funding Opportunity. For the Letter of Interest beginning in 2023, the Thriving Communities Program will provide technical assistance, planning, and capacity building support to teams of community partners that may lack the staffing or technical expertise to scope, fund, and develop infrastructure projects that advance broader community goals. TCP will provide two years of deep-dive assistance to selected communities to help them plan and develop a pipeline of comprehensive transportation, housing, and community revitalization activities. There is no cost to receive this support but interested applicants must identify community partners and together submit a Letter of Interest (LOI) by December 6, 2022, to be considered for selection. For the Notice of Funding Opportunity the USDOT will fund organizations to provide technical assistance, planning, and capacity building support to enable selected recipient communities to plan and develop transportation and community revitalization activities that: increase mobility, reduce pollution from transportation sources, expand affordable transportation options, facilitate efficient land use, preserve or expand jobs, improve housing conditions, enhance connections to health care,

- education, and food security, and improve health outcomes. NOFO is open October 6, 2022, through November 22, 2022, for those wishing to apply to become a capacity builder. Cooperative agreements between \$3.5M and \$6M will be awarded to up to six capacity building teams.
- d. Strengthening Mobility and Revolutionizing Transportation (SMART) Grants The SMART program was established to provide grants to eligible public sector agencies to conduct demonstration projects focused on advanced smart community technologies and systems in order to improve transportation efficiency and safety. \$100M appropriated annually for fiscal years (FY) 2022-2026. The following are eligible to apply: states, political subdivision of a state, tribal government, public transit agency or authority, public toll authority, MPOs, and a group of 2 or more eligible entities detailed above. Eligible projects include: coordinated automation, connected vehicles, sensors, systems integration, delivery/logistics, innovative aviation, smart grid, and traffic signals. - e. 2022 Transit Safety Performance Targets FTÅ's published Public Transportation Agency Safety Plan Final Rule requires certain operators of public transportation systems that receive federal funds under FTA's Urbanized Area Formula Grants to develop safety plans that include the processes and procedures to implement Safety Management Systems. These targets are updated annually. The Niagara Frontier Transportation Authority (NFTA) Executive Safety Committee has officially adopted updated safety targets for the seven established transit safety categories in the NFTA Metro Agency Safety Plan dated February 24, 2022. Policy Committee must agree to support NFTA's updated 2022 targets. The Transit Safety Performance Targets will go to PCC for recommendation to Policy Committee on November 2.

The Bipartisan Infrastructure Law (BIL) has significantly increased funding for rail projects \$7.2 Billion available annually for next five years. Planning funds are available are FRA's CRISI & Corridor ID Program. The GBNRTC has submitted a letter of support and will participate in the new FRA Corridor Identification and Development Program. GBNRTC Passenger Rail Working Group held its kickoff meeting at GBNRTC on September 8, 2022. Participants included Erie and Niagara Counties, NYSDOT, NFTA, Niagara Falls, and ESPA. There is strong interest in pursuing Buffalo-Niagara-Toronto corridor. The group may consider Niagara Falls-Buffalo-Cleveland corridor for increased competitiveness. 
