1. Approval of December 16, 2020 TPS Meeting Summary - Motion for approval: Svilokos/Skipper. Approved.

#### 2. 2020-2024 TIP Discussion

- a. PIN 5814.53 Rt 952Q (Walden Av); Town of Lancaster; Safety Improvements This is a NYSDOT request, that was previously tabled, for a new project that will make modifications in the target area to decrease identified collisions and improve safety and operation. The project will also restore the pavement condition to at least of score of 8 (or higher) using an effective pavement treatment which provides a service life of at least 8 years. Total project cost is \$2.555M (\$2.093M Federal + Match). Fiscal constraint is maintained as offset is being provided by PIN 5B15.55 PMI Pavement Maintenance Let & VPP Block Fund (\$2.109M) and PIN 5B20.06 HSIP/NHPP State Safety Program Block Fund (\$0.446M). Project is scheduled to be let 8/2022. *Motion to initiate a 20 day public review: Buffamonte/Allen. Approved.*
- b. NFTA 3 New Transit Projects This is a request by the NFTA to add 3 new projects to the TIP. 1. PIN 5825.11 Erie Canal Harbor Station Rehabilitation This project will complete design to rehabilitate the existing inbound and outbound Erie Canal Harbor Metro Rail Station structures which are beyond their useful life and in need of rehabilitation due to age. Total cost: \$300K. Let will be 6/1/2021. 2. PIN 5825.12 Operations Control Center (OCC) Enhancements The existing train control monitoring system located at the NFTA's Operations Control Center utilizes obsolete technology and is beyond its useful life. This project will update the NFTA's train control command equipment and workstations. Total cost: \$300K. Let will be 6/1/2021. 3. PIN 5825.13 Boiler Replacement; Cold Spring Garage Two existing hot water boilers used to heat the Cold Spring Bus Maintenance Facility are beyond their useful life and will be replaced. Total cost: \$200K. Let will be 6/1/2021. Fiscal constraint is maintained as 100% of funding comes from outside of regional allocations SFY20/21 NYSDOT Public Transportation Modernization and Enhancement Program. *Motion to initiate a 30 day public review: Amplement/Svilokos. Approved.*
- c. PIN 5809.73 BNRAMS/ITS Enhancements This is a NYSDOT request to add \$0.445M to C&CI for PIN 5809.73. Funding will be transferred from PIN 5813.74 ITS System Rehabilitation; SFY22/23. Offset made possible by previous move of PIN 5814.39 Rt 240/277; Rt 20 to New Armour Duells Rd, from FFY21 to FFY22. Fiscal constraint is maintained and there is no change in let date 3/25/2021. *Motion to approve as Administrative Modification #74: Buffamonte/Helser*.
- d. PIN TWSW.20 Pavement Striping on I-90 & I-190 This NYSTA project was not progressed last year. The Construction & Construction Inspection phases of this project will be delayed from FFY20 to FFY21. The overall costs of the C&CI phases will be increased by \$129K. Fiscal constraint is maintained as the additional \$129K will come from an increased Main Office NHPP allocation. *Motion to approve as Administrative Modification #75: Buffamonte/Helser*.

#### Old Business

a. Freight Study Update – R. Guarino stated that the study is 88% complete. Task 1 Regional Freight and Logistics Status-100% complete. Task 2 Making the Case for Freight Investments in WNY – 100% complete. Task 3 Regional Freight Stakeholder Input and Analysis – 100% complete. Task 4 GAP Analysis and Project Development (64% Complete). Steering Committee comments incorporated. The consulting team is developing a series of Freight Project Sheets that will accompany the final report. Safety analysis of roads around intermodal facilities has been completed by GBNRTC. Remaining items to be completed – Finalize the preparation of a final report that includes an Executive Summary, Project Sheets, and previous tech memos and appendices. #### 2. 2020-2024 TIP Discussion

- a. PIN 5131.39 Rt 277 (Union Rd) @ Rt 33 Ramps This is a significant scope change to an existing project. The scope will now include ADA compliance, signal work and resurfacing of Union Rd from George Urban Blvd to Genesee St. The new project title will be Rt 277 (Union Rd) @ Rt 33 Ramps & Union Rd; George Urban Blvd Genesee St to reflect this change. The resulting C&CI costs will increase by \$1.101M. Funding offset provided from PIN 5B20.06 HSIP / NHPP State Safety Program Block Fund (\$0.112M). PIN 5B15.55 PMI-Pavt Maint Let & VPP Block Fund (\$0.998M). Fiscal constraint is maintained. Let remains 4/8/2021. *Motion to initiate a 20 day public review: Buffamonte/Helser. Approved.*
- b. PIN 5813.48 Niagara Street & John B Daly Blvd This is a significant scope change to an existing project. This request is to increase C&CI by \$1.046M to add six (6) signal replacements which includes the intersection of John B Daly Blvd and Rainbow Blvd. The additional \$1.046M will be transferred from PIN 5B20.06 HSIP/NHPP State Safety Program Block Fund (0.270M) & PIN 5B20.03 State Infrastructure Program Block Fund (0.776M). Fiscal constraint is maintained. Let remains 4/22/2021. *Motion to initiate a 20 day public review: Buffamonte/DeSantis. Approved.*

- b. Local Projects Meetings Status These meetings are an opportunity to identify and correct potential project bottlenecks to keep them moving and stay on schedule. It is also a way to notify local agencies of upcoming funding opportunities, add new projects, increase scope of existing projects, fill funding gaps in existing projects, and add federal funds to local projects. All meetings will be completed by this afternoon. The next round of meetings will be held in June. LP Meetings are held three times a year.
- c. Freight Study Update R. Guarino stated that the consultant is finalizing the preparation of a final report that includes an Executive Summary, Project Sheets, and previous tech memos and appendices. They will be looking to schedule a Steering Committee meeting to present the freight findings and projects. T consultant will be working with GBNRTC and ITGO on participating in a freight forum to present findings from the Freight Study Update.
- d. BRIDGE NY This funding is now available to all municipalities authorized to receive and administer state and federal transportation funding. The announcement and materials are available online and includes NOFA, worksheets, FAQ, training (PDF) and application. More information can be found at <a href="https://www.dot.ny.gov/bridgeny">https://www.dot.ny.gov/bridgeny</a>. A sponsor training webinar was held yesterday. Deadlines are as follows: Pre-review 4/14 culverts and 5/5 bridges and final application 5/19 culverts and 6/9 bridges.

#### 4. New Business

FFY21 Additional Highway & Transit Appropriations – A. Full-Year Obligation Limitation Distribution – The obligation limitations for the full fiscal year for highways remains the same as FFY 2020, the last year of the FAST Act, which is \$46.4B. B. Highway Infrastructure Program Funds – Beyond the obligation limitation for highways, there is an additional \$2 billion of FHWA Highway Improvement Program funds. This is funded with Budget Authority (not Contract Authority) from the General Fund. Slightly more than half of the Highway Extra General Fund (\$1.1B) is for bridge replacement and rehabilitation in qualifying states (i.e., those states in which the percentage of total deck area of bridges or the percentage of total bridges is classified as poor is above 5%) including \$35.8M for NYS. An additional \$640M is made available to the states consistent with the Surface Transportation Block Grant Program, and will include suballocation to the MPOs serving Transportation Management Areas. There has been no decision by NYSDOT on how to allocate these funds. C. Coronavirus Response and Relief Supplemental Appropriations Act, 2021 - The CRRSAA includes an additional \$10B for highways. The vast majority of this funding (\$9.84B) is apportioned to states consistent with the Surface Transportation Block Grant Program of which slightly less than 15% will be suballocated to MPOs serving TMAs. These funds can be applied to projects at a federal share of up to 100% at the option of the recipient, which is the state. These funds are to be apportioned by FHWA within 30 days and can be used for costs related to preventive maintenance, routine maintenance, operations, personnel, including salaries of employees (including those employees who have been placed on administrative leave) or contractors, debt service payments, availability payments, and coverage for other revenue losses. There has been no decision by NYSDOT on how to allocate these the \$417M made available to NYS.

- b. 2021/2022 State Budget & Capital Plan COVID 19 changed the trajectory of the economy from the longest expansion in history to a near complete shutdown as the pandemic began to spread in March 2020. At this time, New York State is facing a revenue loss of \$39B over the next four years that is directly attributable to COVID 19. The two year capital program that was agreed to last year (prior to COVID 19 and with uncertainty in the status of the federal surface transportation program) is still being honored. Of the approximately \$12B over the two years of the program, \$10.5B of that will be used for new construction and obligations within that two year period. Approximately half of the two year capital program will be invested in upstate with comparable amounts for local programs, exclusive of Extreme Winter Recovery funds which have never been included in the Executive Budget and were added by the Legislature. Seventy-five percent of the original 20% that was cut from local programs (\$90M of the \$120M) will be restored. Barring unforeseen circumstances related to COVID 19, there is no plan to withhold funding from local programs in SFY 2022. The percentages of State Transit Operating Assistance to be restored to transit operators has not been determined yet. The proposed transit capital programs will remain the same as the current year with the exception of a \$6M study that will not be carried forward. The Executive Budget proposes approximately \$72M for freight programs, including support for Amtrak and 100% funded passenger and freight rail improvements. A one year \$100M competitive upstate aviation program is included in the Executive Budget.
- c. TAP/CMAQ Program Update NYSDOT MO had nothing to announce as of the MPO Director's call on 2/5/2021. The Governor will announce program soon, so it is too early to define a timeline. NYSDOT is currently looking at the program instructions to see if anything needs to be updated. It is likely that there will be an increased emphasis on carbon reduction/climate impacts and resiliency of project proposals.
- d. 2021 Rail & Port Grants NYSDOT is soliciting candidate projects for funding under the Passenger and Freight Rail Assistance Program (PFRAP \$85.5M available) and the Section 130 Railway-Highway Grade Crossing Program (\$1.5M available). The PFRAP program provides enhanced assistance for rail and port capital investments to preserve and enhance the State's major trade and passenger corridors. This program requires a Benefit-Cost Analysis to be completed. The Section 130 Program will be targeted to the improvement of grade crossing surfaces at public crossings. # 2. Action Items

#### PIN 5825.18 METRO Bus Fare Collection Upgrade

- This NFTA request seeks to modify one existing project.
- This project is currently 100% funded with \$2.026M of NYSDOT 20/21 Modernization and Enhancement Program (MEP) funding.
- \$900K of additional NYSDOT 20/21 MEP funds will be added to the project.
- New project total will be \$2.926M.
- Fiscal constraint is maintained.
- Let is unchanged at 4/21.
- Today's TPS action is to recommend this cost increase as AdMod #83 to PCC for approval at the May 5 meeting.

#### PIN 5900.36 Purchase Revenue Vehicles

- This NFTA request seeks to modify one existing project.
- This project currently uses matched federal FTA 5339 funds totaling \$0.457M
- \$5.07M of NYSDOT 20/21 Accelerated Transit Capital (ATC) funds will be added to the project.
- New project total will be \$5.53M.
- Fiscal constraint is maintained.
- Let is unchanged at 4/21.
- Today's TPS action is to recommend this cost increase as AdMod #84 to PCC for approval at the May 5 meeting.

#### PIN 5900.54 NFTA Battery Electric Bus Purchase – CMAQ

- Per NYSDOT MO request, this NFTA request will switch the VW Settlement funds funding source from federal "FA (Other)" to "Local" per NYSDOT MO instructions.
- This change is administrative only and is necessary to correctly modify the previous project change (11 CNG to 10 BEV) in eSTIP.
- Total project cost (\$10.161M) is unchanged.
- Fiscal constraint is maintained.
- Today's TPS action is to approve this funding source change as AdMod #85.

#### PIN 5813.07 ADA Compliance & Ped Signal Upgrades

- This is a NYSDOT request for a minor scope change to an existing project.
- This project will improve pedestrian mobility by bringing various locations into compliance with the Americans with Disabilities Act (ADA) requirements for accessibility.
- This project currently covers all four western NY counties.
- This change removes work in Cattaraugus & Chautauqua counties, leaving Erie & Niagara.
- Project cost will be reduced by \$1.028M which will be transferred into a new ADA Compliance & Ped Signal Upgrades project for Cattaraugus & Chautauqua counties (PIN 5814.60 which is outside of the MPO).
- The new project total is \$1.447M
- Let date is unchanged at 6/17/21
- Today's TPS action is to recommend this minor scope change as AdMod #86 for approval to PCC at their 5/5/21 meeting.

# 3. Old Business

### Identification of Possible Project Accelerations/Modifications

- FFY21 Federal Appropriations
  - Highway Infrastructure Program Funds
    - An additional \$640 million is made available to the states consistent with the Surface Transportation Block Grant Program, and will include suballocation to the MPOs serving Transportation Management Areas.
  - Coronavirus Response and Relief Supplemental Appropriations Act, 2021
    - The CRRSAA includes an additional \$10 billion for highways.
    - The vast majority of this funding (\$9.84 billion) is apportioned to states consistent with the Surface Transportation Block Grant Program of which slightly less than 15 percent will be suballocated to MPOs serving TMAs.
- There has been no decision by NYSDOT on how to allocate these funds.
- Looking to Identify Possible Project Accelerations/Modifications

## Freight Study Update / Progress Report

- 95% Complete
- Reorganized the draft report based on initial feedback, restructured project sheets into infrastructure projects and non-infrastructure or planning and policy recommendations.
- Received and addressed final report comments from Steering Committee members (Niagara County, NYSDOT, ITGO, Erie County).
- Made final revisions to the final report, and next will schedule a meeting to present the final plan to the Steering Committee.
- Will make one last final update to the freight stakeholder list so that it is current.
- Recommendations already being utilized in TIP development and grant applications.

# RAISE Discretionary Grants

- Rebuilding American Infrastructure with Sustainability and Equity (RAISE)
- The grant program, formerly known as BUILD and TIGER, has awarded over \$8.935 billion in grants to projects in all 50 states, the District of Columbia and Puerto Rico since 2009.
- \$1B available to modernize and create new American infrastructure.
- Project applications will be evaluated based on merit criteria that include safety, environmental sustainability, quality of life, economic competitiveness, state of good repair, innovation, and partnership.
- The maximum award for all projects is \$25 million. Not more than \$100 million can be awarded to a single State.
- For capital projects located in urban areas, the minimum award is \$5 million. There is no minimum award size for planning grants.
- Up to \$30 million will be awarded to planning grants, including at least \$10 million to Areas of Persistent Poverty.
- Not more than 50 percent (\$500 million) will be spent on projects located in urban and rural areas, respectively.

PIN 5763.11 Wehrle Dr; Harlem Rd (Rt 240) – Aero Dr. Increase the project by \$1.05M to cover improved pedestrian/bike accommodations for Wehrle Dr. Project is adding a minimum of 4 foot wide shoulders, with sidewalk curbed areas as well. 2. PIN 5813.14 Pavt Markings (South/Line 2); Various Locations; Catt, Chaut & Erie Counties. Increase C & CI by \$0.443M to match current project needs. Addition of high visibility markings at signalized intersections, with three or more lanes and hatching in gore areas and center medians. 3. Traffic Counting Program – 2021 Traffic count program is underway. From April 26th to May 28th 72 ATR counts have been completed including locations in Buffalo, Amherst, & West Seneca. Counts will be continually collected through October 2021. Intersection turning movement counts are also currently being collected.
