- 2. 2014-2018 TIP TPS Action Requests
 - a. PIN 5757.10 Lockport Rd Intersection Resurfacing and Resurfacing Phases I & 2 and 5757.13 Lincoln Ave Corridor Improvements Cost Increase/Funding Transfer Request R. Eakin explained the exchange of funds between the two projects by using more local funds on the Lincoln Av project and moving the federal-aid funds to the Lockport Rd project. *Motion to transfer funding as Administrative Modification #31: Sickler/Kempner. Approved.*
 - b. PIN 5758.32 Wilson-Burt Rd Bridge Cost Increase/Funding Transfer Requests
 - 1) PINs 5758.57 Feigle Rd Pavement Rehab and 5758.32 Wilson Burt/18 Mile Creek STP Flex Funding Transfer T. Trabold explained the transfer of funds between these two projects needed to help cover a deficit on the Feigle Rd project. *Motion to Recommend to PCC as Administrative Modification #32: Sickler/Merlo. Approved.*
 - 2) PINs 5757.13 Lincoln Ave Corridor Improvements and 5758.57 Feigle Rd Pavement Rehab Large Urban Funding Transfer See item 2b1.
 - c. PINs 5811.50, 5811.51, 5811.83 & 5811.84 Culvert Repair/Replacement Cost and Schedule Changes R. Kahi explained that this item involved transferring funds and a change in the project's let date. Funding from this project is to be transferred to create a new culvert repair project PIN 5812.73. *Motion to recommend changes to PINs 5811.50, 5811.51, 5811.83, & 5811.84 to PCC: DeSantis/Merlo. Approved. Motion to initiate public review as part of 2014-2018 TIP Amendment #20: Kahi/DeSantis. Approved.*

- a. Program Status
 - 1) Pavement Maintenance Module: Status T. Trabold gave a brief update on the status of the new software program. The software company made new changes to the program and additional time is needed by staff to learn the updates. It was also noted that the local agencies were asked to provide the GBNRTC with cost data for the treatment types that will be used in the new program. J. Buffamonte suggested using NYSDOT's cost information temporarily until the local agencies can provide their costs. R. Kahi reminded the group that there are many variables in the cost calculations such as additional ADA costs for intersection rehabs.
 - 2) Safety: Bridge and Accidents T. Trabold discussed the bridge maintenance program. He reminded the local agencies that they should continue to maintain a list of possible bridge candidates for the program. These lists should then be submitted to NYSDOT so they can be evaluated to decide which bridges will be included in the program. Bridge program candidate lists should be submitted by the February TPS meeting.

- 2. 2014-2018 TIP TPS Action Requests
 - a. <u>PIN 5756.34 Bailey Av Bridges</u> P. Merlo discussed the opportunity to advance the project let date now that new NHPP funds from the Statewide Capital Program have been made available for the project in FFY16. This action will also increase the construction and inspection funding without any need of an offset funding source. *Motion to recommend the schedule change and cost increase to PCC as Administrative Modification #34: Merlo/Sickler. Approved.*
 - b. Amendment #20 PIN 5812.73 Large Culvert Repairs Invert Paving Project Addition
 - Public Comment Period Feedback T. Trabold reported the public comment period had ended and there were no comments submitted. The next action in the creation of the new project was to approve the transfer of \$536k of unused funds from PINs 5392.41 & 5041.01 to from the new PIN 5812.73. Motion to approve funding transfer to create new PIN 5812.73 as 2014-2018 TIP Amendment #20: Zakrzewski/Merlo. Approved.
 - Resolution 2015-1: PIN 5812.73 Large Culvert Repairs (Invert Paving) T. Trabold explained that at their 2/4/15 meeting PCC members delegated authority to TPS members to review any public comments and if appropriate, vote to recommend approval to the Policy Committee of the resolution adding the new culvert project (5812.73) to the TIP. Resolution 2015-1 was distributed and discussed. Motion to recommend approval of GBNRTC Resolution 2015-1 to the Policy Committee: Kempner/Sickler. Approved. Policy member ballots were distributed.
 - c. <u>PINs 5811.51, 5811.83 & 5811.84 Culvert Repair/Replacement</u> Cost and Schedule Changes T. Trabold explained that the action essentially moved existing culverts projects (and their funding) to future years if there were any perceived ROW issues involved. The net change was \$1.98M worth of projects shifting from PINs 5811.51 & 5811.83 (FFY16) to PIN 5811.84 (FFY17). *Motion to recommend changes to PINs 5811.51, 5811.83, & 5811.84 to PCC as Administrative Modification #33: Buffamonte/Zakrzewski. Approved.*
 - d. PIN 5760.81 Niagara St, Porter Av to Ontario St T. Trabold explained that \$5.840M of committed NHPP construction and inspection funds from the Statewide Capital Program were just made available for this project, therefore the let date could be advanced to FFY16.

 Motion to approve the schedule change as Administrative Modification #35: Sickler/Kempner. Approved.

3. 2017-2021 TIP

- a. Program Status
 - 1) Pavement Maintenance Module: Status S. Szopinski gave a demonstration of the MS2 Pavement Management System module. He stated that the program once fully up and running should be able to replicate the information found in the Highway Condition Assessment Report produced by the GBNRTC. Along with that information the program will eventually be used as a means of calculating costs for varying maintenance programs. He agreed to provide members guidance on what user inputs can be customized such as pavement treatments and unit costs.
 - 2) Safety Performance Measures H. Boggio reviewed the safety performance measures announced last year. He stated that NYSDOT had issued comments for USDOT to review. Starting in September 2016 the MPOs, in coordination with the state DOTs, have six months to support the targets or come up with their own planning targets.
 - 3) Local Bridge Maintenance Program J. Buffamonte indicated NYSDOT was enthused with the response to their request for candidate submissions.
 - 4) FFY 2015 FTA Apportionments D. Kempner reported the NFTA was still analyzing FTA FFY 2015 apportionments recently released. If transit program changes are needed they will be submitted at a future meeting.
- b. Local Project Meeting Issues
 - 1) PIN 5759.87 Elk St Bridge Repairs During the latest local project review the City of Buffalo expressed concern that design work on this project could not start until construction funds were moved onto the current TIP. NYSDOT agreed to look into the basis for that decision.
 - 2) PIN 5757.09 Lockport St The City of Niagara Falls stated this project needs more money to start this project. They have already made scope changes to shorten the limits but there is still a shortage of funds.
 - 3) PIN 5758.28 Rt 265 over Cayuga Creek Bridge Repairs See below.
 - 4) PIN 5758.29 Pine Av/Gill Creek Bridge Repairs J. Buffamonte suggested they combine these two bridge repair projects (PIN 5758.28 & PIN 5758.29) and the money saved could make up the funding shortage on PIN 5757.09 Lockport St. NYSDOT will work Niagara Falls to resolve this.

 - a. J. Buffamonte announced that local project agreements would now be handled by the planning group. He also stated they have a new method for tracking the progress of the agreements. Member agencies were asked to make sure their local match was secured before starting the agreement process.

 - b. PIN 5761.04 Erie County Shoreline Trail P. Gavin stated that this item was being submitted to correct a mistake made on the original IPP. This change form would increase the PE by \$100K and decrease ROW, C & CI by a total of \$102K. *Motion to approve the change as Administrative Modification #36: Sickler/Merlo. Approved.*
 - c. Local Bridge Maintenance Program Status P. Gavin discussed the latest local bridge program projects to be added to the TIP. He stated there were still some minor changes that needed to be made before the list goes out for public review. The group agreed that after the changes were made the list should be recommended to PCC to initiate public review. *Motion to recommend local bridge program list to PCC to initiate public review: Sickler/Merlo. Approved.*

3. 2017-2021 TIP

- a. Program Status
 - 1) Safety H. Boggio gave a brief description of the performance measures used to determine the safety aspect of a project. He stated that the safety data showed a random pattern of accidents for the area.
 - 2) Bike/Ped K. Smith discussed the Bike Level of Service update that will be performed this year after the pavement maintenance data has been updated
 - 3) Pavement Maintenance K. Stilwell stated that the pavement data will be updated this year so there will be more current information available.
 - 4) Capacity M. Grabau explained how the regional model could be used to evaluate capacity and LOS for the region.
 - 5) Air Quality M. Grabau discussed the use of Mobile 6 vs MOVES for calculating emissions for the region. The region is currently in attainment but if air quality measurements are needed we could enlist the help of NYSDOT's main office to guide us through the process.
 - 6) Freight Movement R. Guarino discussed the freight movement issue. He stated that data collection is getting better which has shown increases in freight movement for the region as a whole.
 - 7) Bridge Maintenance R. Guarino stated that we would be able to get data from NYSDOT from the sufficiency rating book to help determine the overall condition of the bridges in the area.

- a. H. Morse asked how local agencies should go about applying for federal aid for eligible projects. He asked that the member agencies reach out to the locals to explain the procedure and answer any questions.

It was noted that the last application was lacking in showing the economic benefit the project would have on the area, making it less competitive nationwide.

2. 2014-2018 TIP - TPS Action Requests

- a. FFY 2015 FTA Apportionments –J. Amplement stated the NFTA was still working on the revisions and was not yet ready to present their item. Therefore there would not be an action for this meeting and he asked that the item be tabled. *Item has been tabled*.
- b. PIN 5807.81, PIN 5807.88, & PIN 5812.56 Bridge Painting, Cleaning and Repairs—R. Kahi gave a brief description of each change request.
 - PIN 5807.81: Bridge Painting, Erie & Niagara Counties Two (2) New Projects and Funding Transfer to Existing Project Funding will be transferred from an existing funding block (5807.81) to create two new projects (5812.79 & 5812.81), as well as be added to a current project (5812.58) to offset its cost increase.
 - PIN 5812.56: General Bridge Repairs in Erie County One (1) New Project 5812.80 Funding will be transferred from an existing funding block (5812.56) to create project (5812.80).
 - PIN 5807.88: Bridge Cleaning @ Various Locations in Erie & Niagara Counties One (1) New Project 5812.93 Funding will be transferred from an existing funding block (5807.88) to create project (5812.93).

Motion to initiate public review for the four new projects as Amendment # 22: Kahi/Amplement. Approved.

- c. PIN 5268.48 Structural Bridge Replacement of Rt. 240 (Harlem Road) over Buffalo River and Pavement Rehabilitation of Rt 240 from Mineral Springs Road to Clinton Street R. Kahi stated that this project replaced NHPP and HSIP funds with statewide FEMA Critical Bridges Over Water (CBOW) funds. A total of \$8.583M in NHPP and HSIP funds (federal share) were removed with a portion transferred to fund three rural projects and remaining funds used to offset negative STIP balance. Motion to switch NHPP & HSIP funds to FEMA CBOW funds as Administrative Modification # 37: Kahi/Merlo. Approved.
- d. PIN 5934.02 Rail Crossings R. Guarino explained that PIN 5934.02 will be accelerated from 10/16 to 9/15 and will need additional funding. \$45K of HSIP Rail funding from PIN 5934.00 will transfer was to PIN 5934.02. It was agreed that the remaining balance would stay under the original PIN 5934.00 for future use as needed. *Motion to approve funding transfer and let date change as Administrative Modification # 38: Buffamonte/Sickler. Approved.*
- e. Planning Grants H. Morse introduced two planning grants to be used by NITTEC for traffic management and incident management on the I-190 and the Peace Bridge. *Motion to recommend to PCC to initiate public review: Merlo/Buffamonte. Approved.*

3. 2017-2021 TIP

a. Current System Condition Analysis Update – R. Guarino presented a GIS-based location overlay map illustrating the various system conditions that staff had compiled to guide upcoming TIP project submissions.

- a. T. Trabold discussed the Bicycle/Pedestrian Count Technology Pilot Program. He stated there will be an upcoming webinar on the types and cost of equipment that can be selected. It was noted that if a company using proprietary equipment and software is chosen that funding might not be available in later years to maintain that relationship.
- b. T. Trabold gave a brief update on the 2015 construction season. He discussed the various projects on the list, explaining their current status.
- c. H. Morse discussed the upcoming TIGER grant program. He stated that the pre-application was due in two weeks and the final application would be due sometime next month.
- d. K. Stilwell announced that the next round of local projects meetings would be scheduled soon. She also noted the 2015 road scoring would be starting soon and local agencies would be contacted about setting up a schedule for that.
- e. K. O'Brien discussed a webinar on road diets. The group discussed various locations where such things can or should have been done.
- f. K. O'Brien asked about the new state budget that included \$750M for the bridge initiative program. R. Kahi stated that this was on the governor's list for the five year program. It was unknown at this time if this fund source is new money or existing funding.

2. 2014-2018 TIP - TPS Action Requests

- a. PIN 5758.25 Ohio Street Lift Bridge M. Finn stated the design phase was underway with the consultant. However the design phase is short funding and they City of Buffalo wanted to transfer \$470K in construction money into the design phase to cover those costs. *Motion to transfer \$470K from construction phase to design phase as Administrative Modification #39: Buffamonte/Sickler. Approved.*
- b. PIN 5760.55 Bridge Washing and Sealing J. Buffamonte explained that this project did not have the correct fund source from the beginning and needed to be corrected. The request was to change the fund source to STP Flex. Motion to change fund sources for part of C&CI as Administrative Modification # 40: Sickler/Amplement. Approved.
- c. PIN 5757.09 Lockport St Resurfacing Project M. DeSantis stated that this project is underfunded. The City of Niagara Falls requested to transfer \$0.738M to this project from PIN 5758.28. C. Renn stated that \$0.250M will also be transferred from PIN 5758.28 to create the Rt. 384 over Cayuga Creek Bridge Repair Project. C Renn further stated that a cost increase of \$0.725M for PIN 5760.23 Local Bridge Maintenance Program SFY 16/17 would come out of the remainder of PIN 5758.28 and from PIN 5758.29. These two projects will be then be deleted as they no longer will have any funding and are no longer needed. *Motion to recommend to PCC for public review as TIP Amendment # 27: DeSantis/Buffamonte. Approved.*
- d. Rt. 384 over Cayuga Creek Bridge Repair Project See item 2c.

2. 2014-2018 TIP - TPS Action Requests

- a. PIN 5807.99 Signal Replacement R. Guarino explained that NYSDOT was requesting to change the funding source to entirely NHPP funds, freeing up the STP Flex funds for other uses. There was also a cost reduction after further review of the project needs and a let date change (Same FFY) to reflect the current schedule. *Motion to change federal funding sources as Administrative Modification #41: Kahi/Zakrzewski. Approved.*
- b. PIN 5580.47 I-290 over Parker Blvd R. Guarino explained that NYSDOT wanted to merge PIN 5580.46 & PIN 5580.47 using PIN 5580.47 for both. There is also a funding source change due to the fact that CBI funds are no longer available to the region. The let date is also changing, but would remain in the same FFY. *Motion to merge projects and change fund sources as Administrative Modification # 42: Kempner/DeSantis. Approved.*
- c. PIN 5T15.37 PMI-PAVT MAINT LET & VPP R. Guarino discussed the pavement block fund split to create 12 new pavement maintenance projects for NYSDOT. A public review period would be necessary before these new projects can be approved by Policy. A map showing all project locations will soon be distributed to members. *Motion to recommend to PCC for public review as TIP Amendment # 28: Zakrzewski/Kempner. Approved.*
- d. PIN 5812.50 Rt. 78, Terrace Blvd. to Geo Urban Blvd R. Guarino explained a scope change for this project to include the removal of an abandoned CSXRR bridge over Rt. 78. Offsets for the price increase of this change will be provided by funds from additional PINs. The let date was moved to FFY17. *Motion to recommend to PCC for public review as TIP Amendment # 29: Sickler/Kempner. Approved.*
- e. PIN 5760.88 Holland Sidewalk Connection R. Guarino explained that this project is adding a ROW phase and the funds will come from the construction phase of the project. Kahi stated that the block fund money is strictly federal funds and that any NYSDOT funds would be added on after a project has been established from the block.
- b. Local Pavement Preservation Block Creation R. Guarino explained the process used to determine the size of a prospective local pavement preservation treatment block. The estimated cost is \$50K per center line mile for preserving each segment. R. Kahi suggested doing the same thing for roads that are less than a 5 to determine what the cost might be to fix those segments. Updated costs will be sent to the GBNRTC to be used to better fine tune this exercise.
